NIGP GCC Meeting Minutes for November 4, 2010

DISCUSSION ITEMS:

<u>General</u>: Travis Lingenfelter no longer an active member of the Chapter. Mohave County is recruiting for a new procurement manager to replace him with the position advertised and posted through 11-09-10.

Cooperative Contracts: Scott Richardson is still struggling with "contract" to a "cooperative contract" issues, i.e. if using a cooperative contract for his agency, wherein the Scope of Work as awarded under the original contract is used – does his agency have to have a new contract to cover the services they will utilize under the cooperative contract? General discussion among members wherein it was revealed that agencies represented differ on this issue. Some agencies require signing off on cooperative specific contract vs. brining the matter before the Board or approving authority. Commonality was "it depends on your agency's attorney's interpretation".

Additional considerations were identified such as does the cooperative comply with A.R.S. requirements and/or are some things not within the cooperative contract that are mandatorily required by your agency? Scott's agency's County Attorney requires the cooperative to sign "County-specific" contract which is secondary.

Optional alternative provided by the group discussion was to address the issue via a supplemental contract, amendment, MOU, or the like.

<u>Targeted Holiday Card</u>: Treasurer offered the potential idea of having the Chapter expand its membership base through targeted outreach such as upcoming holiday e-cards, invitations to organizational events, etc. Scott advised he would work with Rick Campau to begin facilitating this goal.

Next Chapter Meeting: Chapter members voted for January 13, 2011 in Prescott. Scott Richardson and Lyle Block confirmed they would be in contact with Dawn Foster to arrange for a meeting venue.
