**AZ-NIGP 5<sup>th</sup> Annual Reverse Trade Show**: This is the Capital Chapter's Reverse Vendor Show. Tony Burgett (Mohave County) will be attending. Mark Dibasi, Michael Carter, and Nancy Colbaugh (MESC) are contemplating attending, if so, it will be one or two of them. Show is scheduled for April 4<sup>th</sup> from 1:00 to 5:00 pm at the Tempe Performing Arts Center. If any Chapter members are interested in attending, please contact Tara Acton.

**March is Procurement Month**: A reminder to Chapter members that the month of March is Procurement Month. What are Chapter entities doing to showcase procurement if anything?

**Mohave County (Annie Newton-Fruhwirth):** A Proclamation before the Board of Supervisors; coordinating end-user trainings as needed; and emailing "Procurement Tips" to end-user departments for better procurement understanding.

**MESC (Mark Dibasi)**: Handed out booklets entitled "Doing Business with Public Entities in Arizona". If Chapter members want more booklets, let Mark Dibasi know and he can order more (no cost).

**Valley Schools (Bill Munch)**: March 9<sup>th</sup> is "Professional Buyer Day" for the Copper Chapter coordinated in City Mesa, Tempe, School Districts, and Tucson. Will ask all Capital and Copper member agencies to participate. Holding a career seminar on March 10<sup>th</sup> in Tempe. This is a full-day seminar with credits that will apply.

### 6. Chapter Vice President's Report (Nancy Colbaugh):

**Leaders-in-the-Loop** — **area 9 Chapter Leaders Call** - Area 9 Chapter Report from the Leaders-in-the-Loop include the states of Colorado, Utah, Nevada, Arizona and New Mexico). This is a round table call to share ideas on what they do, reporting deadlines, and feedback from other chapters. Two main ideas shared included:

**New Mexico** – Discussed doing a chapter swap wherein a chapter in Kentucky would pay for a New Mexico chapter to come to them and discuss/train on how they retain people, recruit for qualified people, etc.

**Colorado** – Proposing that if a chapter's member serves on a committee, they should earn points. Same would apply for chapter members who attend seminars, recruit, attend reverse trade shows, etc.

Nancy Colbaugh suggested that maybe the Grand Canyon Chapter plan for a 2017 Procurement Month Event in March and invite Northern AZ-based vendors, including out of Maricopa. Additionally, she advised that there are eight (8) new classes scheduled that our membership can access. Seven (7) of these are 1-day classes. And, during this call, the Capital Chapter stated they were agreeable to assisting our Chapter via Thelma Reyes, who works for the Central Arizona Project. She would help coordinate matters between the two chapters.
