APPROVAL OF PREVIOUS MEETING MINUTES FOR JANUARY 2013: Unanimous

INTRODUCTION OF MEMBERS & GUESTS:

GCC COMMITTEE CHAIR REPORTS:

- <u>Treasurer</u>: Fraud credit in amount of \$882.00 removed by Wells Fargo and deemed "legitimate authorized expenses". Follow-up by Terri Williams with Wells Fargo Account Representative (Senior VP) at Wells Fargo who handles Mohave County's Banking account in order to resolve.
- Outreach: No new action to report as Kingman Unified School District is at a very busy time just now with MESC addressing needs.
- <u>Education/Certification/Awards</u>: Scott unable to attend. President Carter will ask Scott directly if there is anything to share with Chapter members.

GUEST PRESENTATION:

Kingman Police Department – Lt. Jim Brice: Presentation of Houston's PD video – Active Shooter: Run, Hide, Fight with overview provided by Lt. Brice on actions and drills to be taken by staff should an active shooter incident take place at your work-site. Was followed by a question and answer period with statistics provided.

DISCUSSION ITEMS:

- Officer Nominations for 05-01-13 Ballots: Verified that currently the Chapter has a maximum term limit of three (3) years for each position. However, due to Chapter growth having slowed due to economy and reduction in budgeted funds for memberships by many government agencies state-wide, this limitation could be modified by Chapter vote.

- Entity Updates: MESC provided updates on its recent Bus, Facility Security, ASPIN, On-line Ordering for Office Supplies, Bus Parts and Vehicle Parts Contracts. Planning on going out to bid for Fuel and ESCOs Valley Schools recently awarded a life insurance contract through ING that is cooperatively available. Mohave County is awaiting approval of its fuel and road patch contracts at its April 2013 Board of Supervisors' meeting. Each of these will be cooperative as well.

NEW BUSINESS / CHAPTER OPEN DISCUSSION:

Kim Aringdale requested information from attendees on how they handle inquiries from vendors who want "every piece of paper" on a given solicitation, and how is staff time factored into provision of this information. Various responses with all conceding that staff time is factored into how costs are calculated and presented to the requestor beforehand in order not to do work without payment in hand.
